Dear Parent/Guardian,

New York State's Dignity for All Students Act (The Dignity Act) is intended to provide students in public schools an educational environment free from discrimination and harassment. It protects against all forms of harassment, particularly those based on a student's actual or perceived race, color, weight, national origin, ethnic group, religion, religious practice, disability, sexual orientation, gender or sex.

The Miller Place Board of Education and Administration are committed to providing an educational and work environment that promotes respect, dignity and equality for all. We as a school community recognize that harassment and bullying are detrimental to student learning and achievement. This behavior interferes with the mission of the District to educate its students and disrupts the operation of the schools. Such behavior affects not only the students or employees who are its targets, but also those individuals who participate in or witness such acts.

To this end, the Board of Education and Administration's Code of Conduct strictly prohibits all forms of discrimination, such as harassment, hazing, and bullying on school grounds, while participating in distance learning, on school buses and all school sponsored activities, programs, and events. All acts of bullying and harassment should be reported to any staff member of the Miller Place School District.

To provide assistance with the Dignity for all Students Act, each building has designated a "Dignity Act Coordinator." Building Coordinators serve as the information source and liaison for each building with regard to the implementation of the legislation.
