Dear Parent and/or Guardian:

Pursuant to Section 3635(2) of the New York State Education Law, a parent must submit a request in writing for transportation to a nonpublic school no later than April 1 of the year preceding the transportation, unless the family moves into the District after April 1, in which case the request must be made within 30 days of establishing residency. Under the Law, it is the parent's responsibility, not the nonpublic school or the public school district's responsibility to make this request. The school district strictly adheres to this law. Therefore, the required form must be filed or postmarked by April 1, 2021 for transportation for the 2021-2022 school year.

Please note that the law specifically states that for late requests, ignorance, forgetfulness, or a belated parental decision to enroll a child in a nonpublic school, are not reasonable explanations under the Law.

Enclosed you will find the form(s) which must be completed, filed, or postmarked with the Transportation Office at the above address no later than April 1, 2021 so transportation arrangements may be made for your child/children to attend private/parochial school for the 2021-2022 school year. It is **necessary** to complete the Miller Place School District form(s), although you may have already submitted a similar form from the private/parochial school or the private/parochial school has submitted a request on your behalf to the District. We require **all** the information requested on the Miller Place School District application to be completed accurately, including a parent or guardian signature and the date signed for our records.

If your child is starting school for the first time in 2021-2022, or if you have newly moved into the Miller Place School District, you must first register your child/children in the District Central Office at the above address. In order to register your child, please check the District website for registration information and forms necessary for registration. Transportation requests cannot be processed until this registration has been completed.
